Red Tape Review – Outline of Process

- 1. Complete Retrospective Analysis/Rule Report (EO 10, III.)
 - Send Rule Report to ARC and IGOV policy advisor no later than September 1st (III., A., iii.)
 - Post Rule Report to agency website (III., B.)
- 2. Prepare Regulatory Analysis for rule repeal or re-promulgation (IV.)
 - Set public hearing date (IV., B., i.)
 - Submit through RMS for publication in the Administrative Bulletin
 - Post final Regulatory Analysis to agency website after public hearing (IV., B., ii.)
- 3. After public hearing on the regulatory analysis, prepare Request to Initiate New Rulemaking (IV.)
 - Select 'Repeal' or 'Re-promulgate' under EO 10 exception (IV., A., vi. and vii.)
 - Submit to ARC and IGOV policy advisor
 - ARC will return completed form if rulemaking is precleared (IV.)
- 4. After preclearance, prepare NOIA
 - The NOIA should repeal an entire rule chapter in item 1 (II.) and, if necessary, repromulgate a rewritten rule chapter in item 2 (III., D.)
 - Submit NOIA normally through RMS
 - Set two public hearings on the new rulemaking (III., B.)
- 5. Proceed along normal rulemaking steps, including holding two public hearings as noticed

New Rulemaking During Moratorium – Outline of Process

- 1. Prepare Regulatory Analysis for new rule (IV.)
 - Set public hearing date (IV., B., i.)
 - Submit through RMS for publication in the Administrative Bulletin
 - Post final Regulatory Analysis to agency website after public hearing (IV., B., ii.)
- 2. After public hearing on the regulatory analysis, prepare Request to Initiate New Rulemaking (IV.)
 - Select appropriate exception and provide additional supporting materials, if necessary (IV., A.)
 - Submit to ARC and IGOV policy advisor
 - ARC will return completed form if rulemaking is precleared (IV.)
- 3. After preclearance, prepare NOIA
 - Submit NOIA normally through RMS
 - Proceed along normal rulemaking steps

New Rulemaking Pursuant to ARC Directive - Outline of Process

- 1. ARC emails direction to initiate new rulemaking to agency
- 2. Prepare Request to Initiate New Rulemaking (IV.)
 - Select "This new rulemaking action was directed by the Administrative Rules Coordinator."
 - Submit to ARC and IGOV policy advisor
 - ARC will return completed form if rulemaking is precleared (IV.)
- 3. After preclearance, prepare NOIA
 - Submit NOIA normally through RMS
 - Proceed along normal rulemaking steps
